Breakdown of costs			
Airfares (Air New Zealand)	\$2203	\$2203	Group travel cost– transport will be provided from LA to Hotel. Transport only provided with group travel. Players are free to make their own bookings if they chose.
Departure from regional centres	\$100 - \$216	Per person	\$100 ex Christchurch and Wellington but dearer between other regional centres and Auckland (return trip) Players may need to seek “cheapie” fares (remember to include check-in bag) once flight details are confirmed.
Accommodation	\$1500 (based on 20 nights)	NZ\$150 (2)	Share twin basis (Note, this amount is dependent on the number of nights @ \$75/ night each person.) Accommodation includes airport transfers and hotel/venue transfers for event only.

Black Shorts	\$70	Limited supply	Players can purchase own if required, must confirm to guidelines for uniform.
Insurance	\$150	Estimated	Insurance costs have increased and there is now an excess per claim. Players need to be aware that NZIHA will not cover the excess and will not submit claims under \$1000. More information has been requested and will be available when received. NZIHA are required to provide proof of medical insurance cover before players can participate.

**Notes:**

- Trial fee & \$500 must be paid separately at February weekends. Preferably by Eftpos/ cash/ credit card.
- Accommodation and food is based on 20 days, this will be adjusted once the departure and returns are finalized.
- The subsidy is based on 14 players in a team, if the roster decreases or increases this amount will adjusted accordingly.
- You also need to be aware that excess baggage could be a huge issue for us this time. Air NZ (and other airlines) have removed the sporting team provisions. The cost per extra bag is \$95 if prebooked or \$200 at the airport at check-in. **The allowance is ONE PIECE at 23 kg.** We are working on this but this is worst case. The cost per extra bag is a “one-way” cost so any purchases in the USA could increase your excess baggage for the return trip.
- Sightseeing etc: This will need to be organised on a team or individual basis (not NZIHA). Applications for officials will be called for when teams are announced.
- All members of the “group” travelling will be required to sign player and or official agreements once teams are final.
- Parents intending to travel and stay at the same hotel will be asked if they are able to volunteer their assistance to help with off rink supervision.

**Players (underage) travelling without parents/guardians will be required to sign a consent giving team management authority to act on behalf in the event of emergency ( ie medical etc) Forms will be available once teams are finalized.**
